THREE'S AND FOUR'S PROGRAM CONTRACT

agree to enroll our child, _____, in
CHUM Co-op Preschool, licensed by the State of Michigan in the name of CHUM Co-op
Preschool. We agree that our registration fee of \$65 is nonrefundable.

We have received electronically and/or by mail and have read the CHUM Constitution developed by CHUM Co-op Preschool (hereinafter referred to as CHUM). We agree to comply with all of the rules, policies, and responsibilities stated therein. CHUM has reserved the right to modify the rules and policies at its sole discretion with 30 days written notice. Such notice requirements shall not be applicable in the event of emergencies or licensing mandates.

The Three's Program is in session from September until May. Preschool will normally begin at 9:15 a.m. and end at 11:30 a.m. on Tuesdays and Thursdays.

The Four's Program is in session from September until May. Preschool will normally begin at 9:15 a.m. and end at 11:45 a.m. on Mondays, Wednesdays, and Fridays.

We agree to pay annual tuition in the amount of **\$952 (3's Program)**, payable in eight equal installments of \$119, each, OR we further agree to pay annual tuition in the amount of **\$1,432 (4AM Program)**, payable in eight equal installments of \$179 each. Installments are due on the 15th day of August (before actual school year or at enrollment), September, October, November, January, February, March, and April. We understand that if payment of a tuition installment is not received by the 20th day of the month in which it is due, a late fee of \$50 must also accompany our payment. We further understand that our payment must be received by the 25th of the month in which it is due for our child to continue attending CHUM.

We acknowledge that CHUM will release our child, _____, to only those persons authorized on the Child Information Card. We further acknowledge agreement with CHUM standard procedures used for the release of children in special circumstances.

Finally, we agree to abide by the rules and regulations governing withdrawals and dismissals set forth in the aforementioned Constitution. We also acknowledge that CHUM may terminate this agreement without notice if our child's continued participation in the program creates a direct problem/disruption to the class and/or threat to the

safety of him/herself, other children, or CHUM staff. In the event that CHUM opts to dismiss our child, tuition will be refunded on a prorated basis from the date of dismissal.

If any provision of this contract and/or the CHUM Constitution are held invalid or unenforceable, it should be ineffective only to the extent of the invalidity, without affecting the validity or enforceability of the remainder of the provision or remaining provisions and the intent of this contract. This contract constitutes the entire agreement among the parties to it and supersedes any prior understandings or agreements. Each party acknowledges and states that no representation, inducement or condition not set forth in this contract has been made or relied on by either party. This contract shall be governed by the laws of the State of Michigan.
